- ⇒ Driver's License, NYS I.D. or Photo ID for you (and your spouse, if married filing jointly)
- ⇒ All income statements: W-2, 1099, 1099-R, Social Security benefits statement and other income sources
- ⇒ Tuition Statement (1098-T) and related expenses from college, vocational, or technical school
- ⇒ Statement from Child Care Provider that includes total paid and provider's tax ID number
- ⇒ Affordable Care Act statements: Forms 1095-A, B, or C
- ⇒ A copy of last year's federal and state returns, if available
- ⇒ Bank account routing numbers or blank check for direct deposit
- ⇒ Investment income is less than \$3,500
